AND WHEREAS, the letter for submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF AISE REGULATIONS, 2014 was issued to the institution on 10.01.2015. The institution submitted affidavit vide letter dated 12.01.2015.

AND WHEREAS, Revised Recognition order was issued for two basic units (each 50 students) to the institution on 21.05.2015.

The institution vide its letter No. 2015/16/29 dated 30.07.2015 has requested this office to reduce the intake of basic units (100 students) to 1 unit (50 students).

AND WHEREAS, the matter regarding reduce in intake was placed in 759th Meeting of WRC held on September 21-22, 2016 and the Committee decided that "Institutions which have requested for reducing intake have to be permitted."

Now, therefore, the intake of the institution is hereby reduce from 2 units (100 students) to 1 unit (50 students) to conduct 1 of B.Ed. course.

If institution contravenes any of the conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition, by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.
